Francesca is the author of academic articles on these topics, published in several international journals, such as the British Journal of Management, the Journal of Economics and Business, and the International Entrepreneurship and Management Journal. Her research has also been presented at numerous international conferences, including the Academy of Management and the European Academy of Management, among others.

Francesca holds an MSc in Management (Summa Cum Laude and Special Acknowledgement), and a BSc in Economics and Management, both from Luiss Guido Carli University in Rome. She also holds a PhD in Management from the Polytechnic University of Marche, with an additional certification as Doctor Europaeus.
