Stefano Breschi è Professore di Applied Economics dal 2011 ed è Direttore dell'Ivernizzi Center for Research on Innovation, Organization, and Strategy (ICRIOS) presso l'Università Bocconi. Tra il 2004 e il 2010 è stato Direttore del programma MSc in Economics and Management of Innovation and Technology (EMIT) presso l'Università Bocconi.
