

**NOTICE OF COMPETITION**  
**FOR THE AWARDING OF 1 SCHOLARSHIP**  
**FOR POSTGRADUATE SPECIALIZATION COURSE**

ART. 1

Given the liberal contribution offered by *Valentino Spa*, SDA Bocconi School of Management announces the competition for the awarding of 1 scholarship worth 57,000 Euro, available to applicants to the Master of Business Administration Program 2019/20 organized and promoted by SDA Bocconi School of Management.

ART. 2

Candidates with a strong interest in pursuing a career in the Luxury sector are eligible to apply for the awarding of the scholarship announced in this competition:

ART. 3

The Scholarship Application Form must be sent through the online Application portal within **22 July 2019**. The Scholarship application must include a Motivation Letter that should demonstrate the candidate's strong interest in attending the Program and in pursuing a career in the Luxury sector.

ART. 4

Consideration will be given only to applicants who have submitted the Application for Admission to the MBA 2019/20 Program together with the required documentation and a motivation letter. To be eligible for the scholarship candidates must have obtained admission to the MBA 2019/20 Program.

ART. 5

The judging panel will consist of members appointed by *SDA Bocconi* and *Valentino Spa*. The following criteria will be used in evaluating the applications:

- analysis of academic and professional record
- analysis of the motivation letter
- results of MBA course selection tests
- results of any interviews/assessment centres which may be requested at the discretion of the judging panel.

ART. 6

The panel's decision will be considered final and unquestionable. The assignment of the scholarship will be formally notified to the beneficiary by the Commission through an assignment letter, once the selection process is completed.

Failure to accept the scholarship, as well as failure to enroll in the MBA Full Time 2019/20 Program by the date stated in the notification letter, would determine the loss of the scholarship.

ART. 7

The winner of the scholarship may be required to carry out an Individual Project at *Valentino Spa*, as envisaged by the MBA Program, after having been selected by *Valentino Spa*.

ART. 8

Tenure of the scholarship will be for the duration of the MBA Program. Payment will occur in accordance with the dates and conditions provided by the judging panel on assignment, subject to the regular completion of the 2019/20 MBA program by the winner.

## ART. 9

Tenure of the scholarship does not constitute any form of subordinated employment by the SDA Bocconi School of Management or by *Valentino Spa* and excludes social security and welfare contributions of any kind. The stated amount of the scholarship shall be intended gross of taxes, if any is due, under the current Italian or the winner's residency country tax laws.

## ART. 10

The scholarship cannot be accumulated with any other post-graduate/specialization scholarship, award or financial support granted by companies or private and public bodies. The winners must self-certify the absence of the above-mentioned accumulation.

The winner must comply with this condition for the whole duration of the MBA Program.

## ART. 11

Application for the scholarship announced in this competition involves full acceptance of the herein conditions.
