

TUITION WAIVER FOR EMMIO OUTSTANDING CANDIDATES WITH A PROVEN EXPERIENCE IN THE AREA OF REPRODUCTIVE HEALTH CARE FOR WOMEN AND YOUTH

SDA Bocconi School of Management is making available **1 partial merit-based tuition waiver up to € 5.000 (20% of the Tuition Fee)** to 2021/22 EMMIO candidates with an interest in the management of International Organizations and a proven experience in the area of reproductive health care for women and youth.

1. Beneficiaries and Requirements

The tuition fee waiver is available to students with an outstanding profile and they should meet the following requirements:

- A strong interest in expanding their knowledge and pursuing their professional career within International Organizations
- A proven experience in the area of reproductive health care for women and youth
- All admissions requirements are met for the participation in the 2021/22 EMMIO Program

Only candidates who have regularly applied within the deadline, producing all required documentation and have been admitted to the 2021/22 EMMIO Program are eligible for the tuition waiver.

2. Incompatibility and Loss of Tuition Waiver

The waiver can be combined with any other scholarship, award, or financial support for specialization courses by public or private organizations or companies if the total amount does not exceed the total registration fee.

The beneficiary must self-certify that the above-mentioned accumulation has not been exceeded. The beneficiary must comply with this condition for the whole duration of the EMMIO Program.

The right to the tuition waiver is subject to the regular completion of the 2021/22 EMMIO program as indicated in the 2021/22 EMMIO Rules.

3. Lodging of Applications and Results

Applications for the tuition waiver must be sent through the dedicated section of the online application, specifying the waiver of interest. Additionally, prospect candidates have to submit a specific motivation letter demonstrating the candidate's strong interest in the management of International Organizations, i.e. through previous professional experience or research activities. The above letter must be sent to emmio@sdabocconi.it with subject **TW EMMIO 2021/22**.

The assignment of the tuition waiver will be formally notified to the beneficiary by the Commission through an assignment letter, no later than the Communication of assignment dates indicated in the table below:

Tuition Waiver Application Time Frames and Communication of Results:

Applications will be evaluated according to the following criteria: analysis of academic and professional record, analysis of the requirements indicated above, results of the EMMIO selection process. The number of assignments to applicants will not be equally divided amongst the different rounds. The final percentage of awarding for each round is at the discretion of the Commission and their decision is final and unquestionable. A limited number of applicants, at the discretion of the Commission, who were not assigned a tuition waiver during their round may be placed on a waiting list and be reconsidered in the following round.

The amount of the tuition waiver assigned (up to 20% of the tuition fee) is at the discretion of the Commission and their decision is final and unquestionable.

4. Acceptance of the conditions

Application for the tuition waiver involves full acceptance of the herein conditions. Under penalty of immediate withdrawal, the candidates must confirm their enrolment in the 2021/22 EMMIO as well as formalize their acceptance of all tuition waiver conditions with the Admissions office by the deadline indicated on the tuition waiver assignment letter.
