

ART. 1 REGISTRATION

1.1 Once every section of this application for registration has been filled out and it has been duly signed, it must be sent by fax, email or by post to:

1.2 Enrollment will be based on an evaluation of candidates CVs. The registration is understood to be completed at the time SDA Bocconi receives this application.

1.3 SDA Bocconi shall confirm receipt of this application to the participant, in the manner which the latter, at its own responsibility, shall indicate under the heading "person to contact" choosing fax or email.

1.4 Applications for registration must be received by **22 October 2019**. However, in exceptional cases, SDA Bocconi shall at its discretion have the ability to accept applications received after the aforesaid deadline: in this event, Article 4.3 shall apply.

1.5 The course shall take place at the premises at Via Bocconi, 8 - Milan, or at the alternative premises indicated in the confirmation mentioned at Article 1.3.

ART. 3 TRACEABILITY OF FINANCIAL TRANSACTIONS

ART. 4 WITHDRAWAL - CANCELLATION - REFUND

4.1 You may cancel your participation in the course by written notice of cancellation within 10 days starting from the deadline mentioned in Article 1.4 by means of sending a letter by priority mail to the address mentioned in Article 1.1, after providing advance notice via fax and/or email in every case: in this event, refund of the amount already paid may be requested.

4.2 In the event that the student expresses the intention not to participate, giving notice of cancellation after the terms mentioned in Article 4.1, there shall be no right to any refund and the fee mentioned in Article 2 must be paid bearing in mind that as an alternative it is possible to:

- attend the next edition of the Course (if applicable) or another SDA Bocconi Course, within one calendar year from the start date of the Course, subject to payment of any balance in price;
- be replaced by another person from the same business, ensuring that all the personal details for the replacement are provided (in writing).

4.3 In the event that an application for registration is received after the deadline, mentioned in Article 1.4, and if accepted by SDA Bocconi, the student shall have neither the right to withdraw nor the right to refund of the sum paid: the fee mentioned in Article 2 must be paid without prejudice to the possibility of attending the next edition of the course (if any) or another SDA Bocconi course within one (calendar) year from the start date of the course, subject to payment of any balance in price.

ART. 5 PROGRAM CHANGES

5.1 SDA Bocconi reserves the discretion to be able to postpone or cancel the planned class providing notification thereof by **1 November 2019** to the fax number or to the email address that the participant, at his own responsibility, shall have indicated under the heading "confirm registration and send the communication to". SDA Bocconi's only obligation in the matter shall be that of refunding the amount already received, expressly excluding any other duty and/or obligation whatsoever.

5.2 Furthermore SDA Bocconi reserves the discretion to be able to amend the program and/or the location of the course and/or to replace the lecturers. In this event, nothing shall be due by SDA Bocconi to the student on any basis.

ART. 6 DISPUTES

All disputes connected in any way with this contract shall be submitted to the jurisdiction of the court for Milan.
